## 1. Call to Order

Mr. Rhodes called the meeting to order at 7:00 p.m.

## 2. Pledge of Allegiance

Students must be active in their school's FFA, Vocational Agriculture, or Environmental Studies program or in the Upstate 4-H. The New-Era Sustainable Farming workshop will provide an introduction to modern sustainable and organic practices, including cutting edge production methods and thoughtful, creative marketing strategies that make small, family farms viable, profitable, and sustainable. New-Era Sustainable Farming will

feature short presentations by the best and brightest of South Carolina's young and successful farmers, highlighting their innovative production techniques and profitable business practices. Only 100 scholarships for the entire upstate were awarded!

## 7. Administrative Section

# A. Maintenance/Construction Update – Mr. Sam Jones

Mr. Jones said that his report had been sent to them in their packets, he asked if there were any questions. There were none. Mr. Jones informed the Board that there was an electrical underground line problem at Dixie High School and that we were working with the town of Due West to get this problem resolved.

# B. Personnel – Ms. Betty Jo Hall

Ms. Hall informed the Board that the administration recommends ratification of 1 continuing contract. Dr. Kolb made a motion to approve the administration's recommendation; this motion was properly seconded and carried unanimously.

## C. Instruction update- Ms. Jean Smith

Ms. Smith told the Board that they had received in their packets the 2012-13 PASS scores, and also the percent of students passing both parts of the HSAP and the AYP report. Ms. Smith said that our school district has a lot to be proud of with the great test scores our students have received. Dr. Wall said that according to the reports Abbeville was above the state in every standard in every

subject, which is a tremendous accomplishment, and we are doing something right, this is something to be extremely proud of.

## D. Financial Update – Ms. Roni Scott

Ms. Scott told the Board that in their packet they had received the financial update and the expenditure report and asked if there were any questions.

Ms. Scott informed the Board that she and Dr. Wall had met with a group in Due West concerning the rate increase in utilities and the surcharge in Due West. The Board members received a report concerning this information.

# E. Mr. Sherwin Johnson – Home Instruction Applications

Mr. Johnson told the Board he had two applicants for home instruction and since both applicants have completed the application and submitted the necessary information, the Administration recommends that the home instruction applications for the students be approved for the 2013-14 school year. Mr. Brooks made a motion to approve the administration's recommendation. This motion was properly seconded and carried unanimously.

#### F. Dr. Sharon Wall – Miscellaneous

Dr. Wall informed the Board that the carpentry class at Abbeville Career Center requests to construct another house this school year. Administration recommends approval of this request. Mr. Burton made a motion to approve the request for the Career Center to construct a house on the school property for the 2013-14 school year. This motion was properly seconded and carried unanimously.

Dr. Wall informed the Board that if there were no objections, the meeting dates in November and April need to be changed due to conflicts with Thanksgiving and spring break. The November meeting date will be November 19, 2013 and the April meeting will be April 15, 2014. **Mr. Brooks made a motion to approve the administration's recommendation to change meeting dates. This motion was properly seconded and carried unanimously.** 

## 8. Miscellaneous from the Board

Mr. Tisdale gave a brief summary of the School Law Conference that he had attended in Charleston.

Mr. Brooks congratulated the kids for the perfect PASS scores they received. He also thanked Dr. Wall for the great start to the new school year.

Mr. Mitchell said he was proud to see all of the children here this early in the school year. He appreciated the hard work from everyone.

Mr. Burton said that he was impressed with the perfect scores and congratulated the children.

Dr. Kolb said it was great to see that many kids have perfect scores and he congratulated them.

Mr. Reynolds said he was looking forward to a positive school year.

Mr. Rhodes reiterated all that had been said concerning the perfect PASS scores. He also said he enjoyed the opening breakfast and looks forward to a great new year.

## 9. Executive Session – Contractual Matter

At 7:52 p.m. Dr. Crenshaw made a motion to go into executive session to discuss a contractual matter. This motion was properly seconded and carried unanimously.

# 10. Return to Open Session

At 8:10 p.m. the Board returned to open session. Dr. Kolb made a motion to accept the administration's recommendation on the contract that was presented with two changes being made in wording, ("up to ten days" and "working with") this motion was properly seconded and carried unanimously.
